### **Position summary**

Justice Centre Hong Kong seeks an NGO development professional with at least ten years experience to support the creation and coordination of an Anti-Human Trafficking Hong Kong Coalition. The Coalition aims to bring together the non-governmental, non-profit and business sectors in Hong Kong to work in a more coordinated approach to achieve improvements in the anti-trafficking legislative framework in Hong Kong.

The role will entail one person acting as a coordinator for the NGO community in the anti-human trafficking and business sector across Hong Kong. Whilst this role will report to the Funders, the Coordinator will be supervised and housed by Justice Centre Hong Kong.

Justice Centre Hong Kong is a non-profit human rights organisation working fearlessly to protect the rights of Hong Kong's most vulnerable forced migrants - refugees, other people seeking protection and survivors of torture, human trafficking and forced labour. - Establish and maintain productive relationships with non-profit actors in Hong Kong working in anti-human trafficking and/or migration related fields in Hong Kong and the region
- Lead the establishment and coordination of the Anti-Human Trafficking Hong Kong Coalition
- Establish and maintain productive relationships with interested business community members in Hong Kong and the region
- Coordinate and prepare joint submissions to the Hong Kong Government and/or International Treaty Bodies on behalf of the Anti-Human Trafficking Hong Kong Coalition
- Coordinate and prepare joint grant proposals on behalf of the Anti-Human Trafficking Hong Kong Coalition
- Coordinate joint projects (including but not limited to small research projects) in support of any submissions or advocacy efforts by the Anti-Human Trafficking Hong Kong Coalition
- Perform other duties as assigned by the Executive Director.

### Essential

- Postgraduate degree in Development or equivalent field experience, with at least ten years' working experience in anti-human trafficking and/or migration related fields
- Demonstrated experience in the area of non-profit work
- Demonstrated networking skills with a wide variety of actors including in the non-profit and private sectors
- Demonstrated research, analysis and reporting experience

- Flexibility, ability to multi-task, prioritise and work under pressure
