### **Job Description**

The Board is the governing body of Justice Centre Hong Kong. As a Board Director you will be responsible for the overall governance and strategic direction of the organisation and for ensuring that the organisation is solvent, well run and delivers against its strategic objectives.

Board Directors are expected to attend six meetings of the board annually, board committee meetings as appropriate, and special events.

- Approve strategic and annual plans and performance targets

### **Oversight and Risk Management**

- Ensure operations are carried out based on ethical standards, consistent with our values and within a socially responsible framework
- Ensure the integrity of financial information with accountability to all stakeholders, that appropriate financial accounts are kept and approve the organisation's annual report and accounts
- Ensure the organization is solvent and that robust financial controls and systems of risk management are in place.

- Publicly support Justice Centre Hong Kong at high profile and/or fundraising events
- Advocate on behalf of the organisation to generate awareness about protection and anti-trafficking issues

# **About Justice Centre Hong Kong**

A non-profit organisation launched in 2014, Justice Centre Hong Kong was formerly Hong Kong Refugee Advice Centre, which over seven years, helped more than 2,000 refugee men, women and children on the road to a new life. Building on our expertise in refugee issues, we identified a clear need for an increased response to tackling forced labour and human trafficking in Hong Kong and expanded our remit to fill this gap.

We advocate with and for forced migrants bringing their voices into the public debate. We campaign for legislative and policy change, conduct research and work with the media and civil society to fight root causes and change systems and minds.

We provide people seeking protection in Hong Kong with free and independent legal information and specialised legal and psychosocial assistance.

We receive no government funding. Instead, we have spearheaded an innovative probono working model that sees leading international law firms provide financial assistance and donate hours to help with legal research and support. We also harness funding from a variety of trusts and foundations and through individual donations.
