## **MOCK TRIAL EXPERIENCE**

Justice Centre is delighted to introduce the Mock Trial Experience. Recognising the importance of engaging young people in human rights work, Justice Centre has been delivering clinical legal education programmes to university and school students since 2009. Using our expertise, we have developed a new opportunity for secondary school students in Hong Kong to learn about and apply human rights and asylum law.

Students will be trained in the law and then participate in a mock trial – a simulation of the Torture Claims Appeal Board/ Non-refoulement Claims Petition Office (TCAB). Participants will be judged by experts in asylum and human rights law in Hong Kong. Justice Centre staff and university student coaches from local law schools will guide and mentor participants.

#### **OBJECTIVES**

By participating in the experience, high school students will:

- Have a better understanding of international refugee law and human rights
- Gain insight into issues facing refugees and asylum seekers in Hong Kong
- Improve their advocacy, teamwork and presentation skills
- Promote Justice Centre's role and vision

### **TCAB HEARINGS**

The TCAB is an independent body (like a court). If someone's claim for non-refoulement protection (like an asylum claim) has been refused by the Immigration Department, they can appeal to/ petition the TCAB. Often, the TCAB will hold a hearing to determine the appeal/ petition. At the hearing, the TCAB will review the evidence and may ask questions of the claimant, witnesses and the legal representatives. The TCAB will then decide whether the appeal should be allowed – whether the claimant should be granted non-refoulement protection.

# **ROLES**

Students will be assigned a role for the mock trial:

- Lawyers (6 roles): students will act as lawyers, representing either the Immigration Department or an asylum seeker. They will prepare questions for the asylum seeker and expert witnesses. They will participate in advocacy - eliciting evidence in-chief, undertaking cross examination/ re-examination, and delivering closing arguments.
- **Experts** (4 roles): students will act as medical or country experts. They will undertake research to better understand their roles and areas of expertise. They will give evidence and be subject to questioning by lawyers and the adjudicators.

Roles will be assigned on the acceptance of students' applications.

# **ELIGIBILITY**

The Mock Trial Experience is open to secondary students based in Hong Kong, currently in Form 4 / Grade 10 or above. It is aimed at those interested in a career in law, human rights, politics, or public policy. Students are not required to have prior public speaking, mooting or advocacy experience.
